The primary objective of the Mirae Asset Korea New Growth Equity Fund (the “Fund”) is to achieve long term growth in the share price through capital appreciation, measured in US Dollars, of the underlying equity portfolio. The Principal Investment Manager will seek to achieve the objective of the Fund by investing mainly in equities and equity related securities of companies domiciled in or exercising a large portion of their economic activity in Korea, and that have strong prospects for growth.

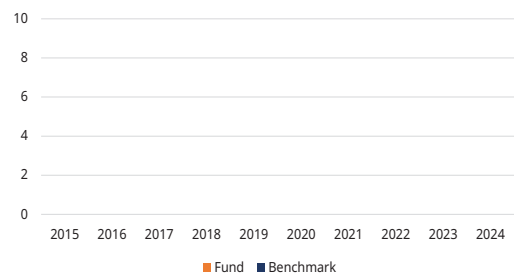

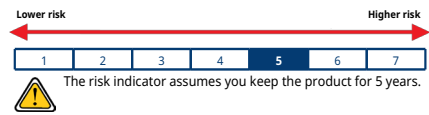
